### **3: Fallon Avenel - New Name & New Device**

*Vert, a frauend Adler Or, a chief checky sable and Or.*



#### 4: Finnech inghean Labhrainn -New Badge

*Gules a thistle Or.*



#### 5: Ishmaell Reed - New Name Change From Holding Name

Originally submitted as “Ishmael Reed,” we have changed the spelling with submitter’s permission to match the available documentation.


#### 6: Lina Lovell - New Name & New Device

*Purpure, a wolf sejant, on chief embattled argent three flowers purpure*



#### 7: Prima da Brescia - New Device

*Azure, a rabbit sejant erect argent maintaining and playing a lute Or, on a chief argent three musical notes azure.*



#### 9: Rose Davidson - New Name & New Device


*Per saltire azure and argent, a rose proper within a massacre Or.*

*Per chevron argent and vert, in base three barrels palewise one and two Or.*




## **Returns:**

### **1: Adeliz Orlog - Resub Device**

*purpur and Or scaly on a chief vert three cogs Or*

This device must be returned for violation of SENA A.3.B.4.a, which states that “Charges must have good contrast with the background on which they are placed.” As the scaly field here is not neutral, but rather purpure marked Or, it does not provide good contrast with the vert chief.



### **2: Rashida bint Daoud al Harbi -New Name & New Device**

*purpure, a domestic cat sejant or, bearing a shamshir or, between three crescents Or.*

This name must be returned for insufficient documentation, as the submitter provided no citation for the proposed documentation of any of the name elements. Per the Administrative Handbook, under Submissions Regulations section IV.C.2,

“Citations must be sufficiently complete to allow identification of the source and its usefulness, which generally includes author, title, and publication information (for print sources) or URL (for online sources). Except for documentation from items in Appendix H (the No-Photocopy List), such documentation must include copies of cited source material.”

As we cannot register a device without a name to register it with, the device must also be returned at this time. On resubmission, we recommend coloring the crescents using a true yellow, rather than orange or gold, for best results.
