*Per chevron argent and vert, two ravens displayed respectant sable and a spearhead argent, on a chief vert three escallops inverted argent.*



### 11: Freydís Róðmarsdóttir -New Name & New Device

*Per Chevron Or and Gules, two compass roses gules and a wolf statant guardant argent.*

*Per pale wavy azure and vert, a tower Or and a bear rampant argent.*

*(Fieldless) A beehive Or.*

*Ermine, three roses and a bordure wavy azure.*

*Per bend azure and gules, a griffin argent and on a chief Or a key*  
*gules*



**19: Ormarr Raumsson** - New Device

*Sable, four annulets in bend sinister Or.*



**20: Siegfried Schmitt** - New Name & New Device

*Per chevron throughout argent and azure, two tricunes inverted sable*  
*and a talbot rampant argent spotted sable.*



## Returns:

### 1: Ælfric Ecgeling -New Device (see ACCEPTANCES for name)

*Or, a cross vert, overall a caucasian satyr sable affonty, maintaining a pen azure.*

This device must be returned for several issues. Firstly, the satyr is barely overall. Per SENA Appendix I, "An overall charge must have a significant portion on the field; a design with a charge that has only a little bit sticking over the edges of an underlying charge is known as "barely overall" and is not registerable." Additionally, the same section of SENA states that "There can be only one overall charge group in any design." In this case, the satyr and maintained pen are separate charge groups. Finally, this must be returned for violation of SENA A.3.B.4.a, which states that "Primary, secondary, and overall charge groups are considered to be placed on the field and must have good contrast with it." While the argent satyr does have good contrast with the vert cross, as an overall charge it must have good contrast with the field, which is Or.



### 2: Andrzej Alekiewicz -New Name & New Device

*Per bend embattled vert and argent, a gauntleted left-hand and a seahorse unicornate counter-changed.*

This name must be returned for insufficient documentation. No documentation was provided for the spelling "Alekie" used in the patronymic.

This device must be returned because by precedent, unicornate seahorses are no longer allowed except in cases where the charge is already registered to the submitter.



### 3: Sven Fenrirson -New Device

*Per pale vert & gules, between two wolf heads in fess respectant, a battle axe argent.*

This device must be returned for two administrative reasons. Firstly, we were unable to find any record of the filing name having been either submitted or registered, and without a name to register the device under the device cannot be registered. Secondly, per the



Admin Handbook, section IV.C.1: "submissions colored with wax-based media such as crayons or wax pencils will be returned."



## **Pends:**

### **1: Aidan of Kilkenny -New Device Change**

*Per pale azure and sable, a dragon rampant tail to base between two arrows, dexter arrow point to base sinister arrow point too chief argent.*

This item is being pended for the duration of one month to allow time to work with the submitter on potential changes to the artwork.



### **2: Katrein Töpffer - New Device (see ACCEPTANCES for name)**

*Argent, a fess wavy between two snail shells and a polypus azure.*

This item is being pended for the duration of one month to allow time to work with the submitter on potential changes to the artwork.
