
## Acceptances:

**1: Ava Deinhardt** -New Name (See RETURNS for device)



**2: Benjamin von Bremen** -New Device

*Per chevron sable and argent, an alphyn passant gules.*



**3: Gabriel Ambrose of Hitchin** - New Name & New Device


*Gules, a wall enarched argent between a lion passant guardant and an annulet Or.*

**4: Lucy of Wigan** -New Name & New Device

*Argent, a raven rising sable--wings addorsed bearing in its beak a sprig of Rowan vert, fructed gules. a Base engrailed gules.*



**5: Nyvein bat Rav Adam** - Resub Name Change



**6: Olivia Trivisana** -New Name & New Device

*Per pale azure and argent, a butterfly counterchanged, and on a chief sable a moon in its plenitude argent between two mullets Or.*

**7: Sadb ingen Chonchobair** - New Household Name

*Sleeping Dragon Inn*

**9: Sigrun Galinsdottir** - New Name


**10: Valdr Arason** - Resub Name & New Device

*Azure, a pall between a fret couped and two wolf's heads erased addorsed argent.*



**10: Vincenzo d'Este -New Device**

*Azure, three fleurs-de-lys inverted and on a chief argent a double headed eagle sable*



**11: Ysabeau de Horres-New Name**

Originally submitted as "Ysabeau d'Horres," we have altered the spelling of the byname to match the available documentation. Submitter allows for "changes to the byname for things similar to it phonetically."

## Returns:

### **1: Atlantia, Kingdom of** -New Order Name

*Lion of the Sea, Order of*

This item has been withdrawn.

### **2: Ava Deinhardt** -New Device (See ACCEPTANCES for name)

*Per chevron rayonny argent and azure, a ram clymant sable.*

Unfortunately, this device must be returned for conflict with the badge of Eric Edgarson, registered in July of 2015 (via Atenveldt): *Lozengy gules and argent, a goat clymant sable.*

While there is one Distinct Change allowed for any change to the field, a second would be required to clear conflict. There is no difference granted between a goat and a ram.
