Acceptances

1: Agatha la sommelière - New Name & New Device

Vert, on a pile Or between a smith's hammer and a spoon conjoined in pile argent a domestic cat's head erased sable.

Originally submitted as Agatha *le Gaspereau*, the byname was changed with permission from the submitter.



2: Aidan of Kilkenny - New Device

Per pale azure and sable, a dragon rampant tail to base between two arrows argent.

This item was pended on the December Letter of Decision and is now being forwarded to Laurel.



3: Ailis inghean Ui Riagain - New Device

Purple, a bee skep, beset by bees between in chief two oak trees eradicated argent.



4: Aleta Sørensaater - New Device

Azure, a lion's head erased contourny within a serpent in annulo vorant of its own tail Or.



5: Andrew mac Talorcan - New Name & New Device

Sable, on a bend sinister azure fimbriated between a decrescent and an increscent three mullets of four points palewise argent.



7: Edric De Vaux -New Name

8: Elspeth of Shepton Mallet - New Device Change

Or, a brown squirrel proper maintaining an acorn vert, on a chief invected vert three thimbles Or.

Old Item: Vert, a bend sinister between a squirrel contourny maintaining an acorn and an annulet of eight thimbles Or., to be released.



9: Elspeth of Shepton Mallet - New Badge

Fieldless, a brown squirrel proper atop an acorn proper, maintaining in its paws a thimble Or.



10: Hallbjorn Eyvindarson - New Name & New Device

Per chevron Or and argent, a chevron azure, in chief two cats sejant erect respectant sable, overall a calamarie gules.



11: Heiðr Bjarnardóttir - New Name

12: Kathleen inghean Mháille - New Name

14: Merewyn Scharp – Device Resubmission

Per chevron inverted vert and azure scaly argent, a sea-lion Or, in chief two escallops argent.



15: Rikitsa Kippsdotter - New Name Change

16: Roderick Mund - New Device

Per pale azure and vert, two dolphins haurient respectant, in chief two pens in saltire argent.



17: Rónán mac Cuilennáin - New Name & New Badge

Gules, a sea-wolf between six crabs two, two and two, a bordure Or.



18: Rose Redd - New Name & New Device

Per chevron inverted argent and azure, a rose gules and a castle of two towers Or.



19: Rùna Skógadóttir - New Name & New Device

Per fess wavy vert and Or, a rabbit and a fox courant counter-courant counterchanged argent and gules marked argent



20: Sabrina Rose - New Name& New Device

Purpure, in fess a roundel between an increscent and decrescent argent, a bordure or



21: Seiffrid Wolfhart - New Device

Argent, a wolf passant sable, on a chief embattled azure three mullets argent.



22: Slaine inghean Ui Sheachnasaigh - New Device

Per chevron vert and sable, on a chevron argent two dogs courant respectant sable, in chief three sunflowers Or.



23: Tatiana Berezetskaia - New Badge

(Fieldless) A birch leaf per saltire vert and argent



24: Þorgrímr kráka - New Name & New Device

Gyronny vert and argent, three ravens rising and a bordure embattled sable



25: Varr Grimsson - New Name & Resub Device

Or, two ravens respectant and a wolf's head erased, a bordure embattled sable.



26: Vigdis Lukasdottir - New Name

27: Ysabeau de Horres -New Device

Per chevron azure and vert, a chevron between three owls Or.



28: Zafira bint Miriam - New Device Change

Per pale purpure and sable, a dumbek and a bordure argent.



Returns

1: Aziz Rasuli -New Name & New Device

Per bend gules and azure, an ass statant argent and a human shin + foot couped argent, pierced with a passion nail Or.

Unfortunately, this name must be returned for insufficient documentation. Neither the given name nor the byname were documented to period, and while religious texts are sometimes a good starting point they are often problematic to use when attempting to document a name or spelling to a particular time and/or culture. Additionally, the name construction needs additional work. We recommend looking at <http://heraldry.sca.org/names/arabic-naming2.htm> as a starting point.

The device must also be returned at this time, as all armory must have a name under which to be registered.



2: Beornwyn Bjarnardóttir - New Device (see ACCEPTANCES for name)

Per fess wavy azure and vert, three polypuses Or.

Unfortunately, this must be returned for conflict with the device of Stephen Hamersmythe of Dragon's End, registered in February of 2013 (via AEthelmeare): *Per pale azure and purple, three polypuses Or.*

There is a Distinct Change for the field, but as two DCs are required for difference, this device must be returned at this time.



3: Wulfwyn of Black Diamond -New Device

sable, on a rondel argent, a paw print sable, a bordure argent.

This device must be returned for conflict with the device of Kolvallr Hergeirsson, registered in April of 2009 (via Trimaris): "Sable, on a plate a clenched gauntlet sable, a bordure argent." While there is one DC for change in type of tertiary charge, two DCs are required to clear conflict.



Pends:

1: Aric de la Flèche - New Name & New Device

Argent, a Roman letter A pierced by an arrow to dexter gules.

This is being pended for the duration of one month, to allow time to collect Legal Name Allowance documentation from the submitter.



2: Roanna de Caerdydd - New Name & New Device

Argent, a magpie proper within an orle azure, a bordure gules platy.

This is being pended for the duration of one month, to allow time to discuss possible changes in spelling with the submitter.
