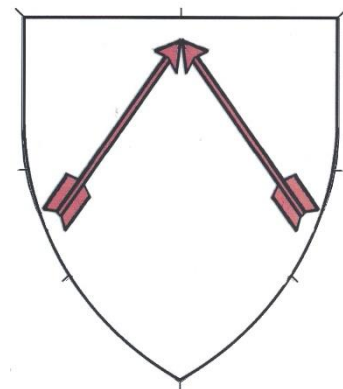

1. Aric de la Flèche -Resub Name

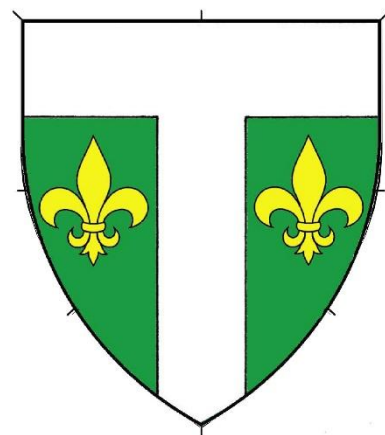
2. Aric de la Flèche -Resub device

*Argent, in chevron two arrows inverted conjoined gules*



3. Jeckel Fett - Resub Device

*Vert, a chief-pale argent between two fleurs-de-lys Or*



4. Mathias von Rothenburg - Resub Name Change

New name submitted Viðarr gylðir

5. Mathias von Rothenburg - Resub Device

*Per saltire sable and azure, in pale two stars of David and in fess two wolves passant respectant argent*



6. Tóla of the Sacred Stone - New Name

7. Tóla of the Sacred Stone - New Device

*Per pale argent and sable, in pale a greyhound courant gules and a wheel counterchanged, a chief engrailed gules*



8. Tors Hartman, ( Hartman Torse) - New Name

## Returns:

### 1. Tors Hartman -Device

*Per bend sinister gules and sable, a massacre argent within a torse wreathed argent and Or.*

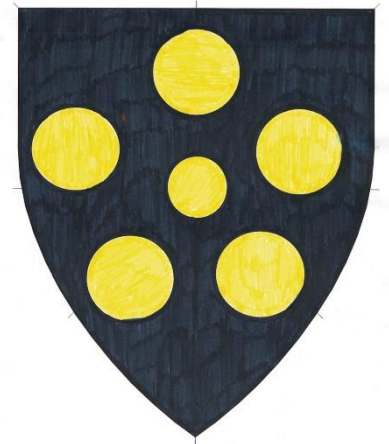
This device unfortunately runs afoul of SENA A3B3d: "Elements not already mentioned must have good contrast between their parts. These include fields or charges evenly divided into four parts other than quarterly or per saltire, fields or charges evenly divided into more than four parts of two different tinctures, and fields or charges unevenly divided into multiple parts of two different tinctures; all of these must have good contrast between adjacent parts of the field. In this case it is the tincture of the torse



### 2. Kanamori no Tatsume -Resub Device

*Sable, five bezant in annulo around a single bezant Or.*

While this was shown in Japanese Heraldry as a Plum Bowl Mon with supporting documentation, it visually conflicts with the protected arms of Cornwall ("Sable bezanty."). In many modern depictions, this also appears depicted as "Sable, fifteen bezants, five, four, three, two and one". Only one possible distinct change for the arrangement of the charges. It was noted that to support the idea that the central bezant should be so much smaller than the five outer one, that few more examples would be helpful, since two of the images provided seem to show the central roundel as noticeably smaller but the other two do not.



### 3. Mathias von Rothenburg -New Badge

This item is returned for redraw /correction of tincture. It was decided that the tusk need greater contrast with the field. Gules was suggested.
