


1. Annice Argent - New Device

Azure, a crocodile statant countourny and an orle argent



2. Bridget O Shea - Resub Device

Argent, a chevron and on a chief azure three mullets of four points argent




3. Hidden Mountain, Barony of - New Order Name

Award of the Purple Cloud


4. Hidden Mountain, Barony of - New Badge

Per chevron argent and purpure, two clouds purpure



5. Marion Compton - Resub Device

Vert, a rose argent within a bordure invected erminois




6. Rowan of Hawkridge - New Household Name

Manoir de la Petite Chapelle

7. Rowan of Hawkridge – New Household Badge

Azure, a Bowen cross, a base embattled argent



8. Tors Hartman - Resub Device

Per bend sinister gules and sable, a stag's massacre within a torse argent.



Returns:

1. Emeludt Hansler -New Device Change

Or, a satyr statant to sinister sable shackled on the wrists with a broken chain argent maintaining on its back a wooden basket and in its hand a besom. This is being returned for identifiability of the charges. The wooden basket, possibly appears to be an early version of an Adirondack pack, which is a period item but would need to be documented. The chains need to be more pronounced. The main charge is not identifiable as a satyr. It was suggested that the Client was going for a Krampus, a period mythological creature. If this the case, the commenters came up with documentation for Krampus along with a redraw that would be acceptable for resubmission, if the Client wishes.



2. Lucia Bellini - New Badge

(fieldless), *On a bell Or, in saltire an artist paintbrush inverted and a quill pen sable* This is being returned for the following two reasons. The first is incomplete form. The submission this was to be associated the household name *Casa Bellini Atlantia LoI - 2006-09-28* with currently has a badge. The form need to reflect the disposition of the old badge. That is a change, not new, and to retain or release the old badge. The second is the identifiability of the artist brush. It was determined that “ the internal detailing that is present in the line art were visible in the color version, it should be identifiable as a brush rather than a dip pen.”
